Dear Sr. Teresa,

I refer to the Exhumation Licence for the exhumation of 133 individuals from St. Mary's Private Graveyard, High Park, Drumcondra, Dublin 9 which was issued on 25th May 1993 by this Department to solicitors acting on behalf of your Order.

A representation was received recently by this Department indicating that there are a number of discrepancies between the names on that exhumation licence and the information on the relevant memorial in Glasnevin Cemetery. In particular, it was suggested that the names on the exhumation order are not all included on the memorial. It would appear reasonable to expect that all the remains identified as part of the exhumation would be commemorated at the place they were re-interred. A copy of the exhumation order, including the list of deceased persons covered by that licence, is included for your convenience.

I would be obliged if you could examine the matter and supply a list of names on the memorial for our records.

LOCAL GOVERNMENT (SANITARY SERVICES) ACT, 1948

COUNTY BOROUGH OF DUBLIN

The Minister for the Environment, in exercise of the powers conferred on him by section 46 of the Local Government (Sanitary Services) Act, 1948, hereby grants licence to Sister Ann Marie Ryan, Superior, Sisters of Our Lady of Charity, High Park, Drumcondra, Dublin 9, for the exhumation of the remains of the deceased persons listed in the Schedule to this Order which are interred in Saint Mary's Private Graveyard, High Park, Drumcondra, Dublin 9, subject to compliance with the following conditions:

1. Each exhumation shall be carried out within twelve months of the date of this licence under the supervision of a person appointed for the purpose of such supervision by Dublin Corporation and in accordance with such directions as may be given by the Eastern Health Board with respect to matters affecting or likely to affect public health.
2. Each of the said remains shall, within forty eight hours after the exhumation, be either:
 - (a) re-interred in Glasnevin Cemetery, Glasnevin, Dublin 11, under the supervision of a person appointed for the purpose of such supervision by Dublin Corporation and in accordance with such directions as may be given by the Eastern Health Board with respect to matters affecting or likely to affect public health, or
 - (b) cremated.
